To have proper discussion, the Chairman requested the Secretary to take up Agenda Item No. 7 as the first item for discussion.

Agenda item No.02: To scrutinize and approve the proposals with or without modifications made by the subject boards with regards to courses of studies, academic regulations, curricula, syllabi and modifications thereof, any instructional and valuation methods, procedures relevant thereto, etc.

The Members were informed about the various Subject Boards constituted under the provisions of the statutes of autonomy. The Boards met and have forwarded revised syllabi and their suggestions.

The credit distribution pattern for various subjects, the alphanumeric codes for various subject heads in each programme and the revised syllabi as approved by each Subject Board for Under-graduate and Post-graduate programmes were placed before the Board. Ms. Urmi Palan explained that the credit distribution pattern was aligned with the current practice at the University of Mumbai to enable lateral and vertical mobility of students from autonomous to non-autonomous institutions and *vice-versa*. The total credit distribution included both contact and notional periods. It was thought prudent not to make major changes in the evaluation pattern and syllabi for the year 2017-18 and any change to be made should be in line with the respective University structure. Ms Urmil informed the Members that the college has a long tradition of recognizing merits and talents of its students by awarding them performance based recognitions in form of certificates / medals / trophies / cash awards etc. The college started many new programmes which are not under grant-in-aid category. Stakeholders and well wishers of the college have expressed a desire to institute parallel award system for these programmes. Thus, she requested Members to give approval to such a provision, so that appropriate awards, scholarships, prizes etc. can be instituted in future.

Resolution No.: AB/1.8.1:

RESOLVED THAT suitable awards, scholarships, prizes etc. be instituted in the college for the students pursuing unaided programmes and courses; through generation of appropriate earmarked funds.
