I/C Principal, Dr. AnushreeLokur welcomed all the Members to the Fifth Academic Council Meeting held on 05 October, 2019 at 11:30 am. She started the meeting by congratulating all the members on Ruia College's win at INT for the 3<sup>rd</sup> consecutive year, specially mentioning Ruia Natyavalay headed by Dr. Manish Hate.

She then introduced the Member Secretary Dr. Sujata Suvarnapatki who took the meet forward. She welcomed all members of the Academic Board and briefed the chair on the composition of the Board, proceeding with introduction of new Members on Board, New Heads of Department of Botany and Economics, Dr. Jessy Pius and Dr. Varsha Malwade respectively.

The Member Secretary then took the meeting forward with the Agenda for the day.

# Agenda item No.01: To confirm the minutes of the previous Academic Council Meeting held on 18<sup>th</sup> March 2019

Before confirming the minutes of the previous meeting, Dr. Sujata Suvarnapatki briefly spoke on the previous meeting and suggestions thereof, and as per recommendation of the last meeting of the Board, it was resolved that Certificate Courses should be awarded 03 credits for minimum 45 hours.

The Minutes of the last meeting, 18 March, 2019, were placed before the members and resolutions passed therewith were reiterated.

• Agenda item No.02: To scrutinize and approve the proposals for the year 2019-20 (Even Semesters) with or without modifications made by the subject boards with regards to courses of studies, academic regulations, curricula, syllabi and modifications thereof, any instructional and valuation methods, procedures relevant thereto, etc.

The members were informed that Board of Studies meeting for this academic year were held simultaneously on predesignated dates and times on 21<sup>st</sup>, 22<sup>nd</sup> and 23<sup>rd</sup> August, 2019, and the entire activity was smoothly and efficiently carried out.

Dr.Suvarnapatki explained that many departments had recomposed their BoS this year and suggestions of previous members as well as those of parents and students, modalities for assessments, review of Question papers and introduction of supplementary Certificate Courses, were all incorporated in the Agendas and unanimously passed by the BoS.

Syllabi for most departments had been passed in the last meeting. Some departments made minor changes, additions / omissions from their syllabi as per suggestions from members given during the previous meeting, as well as to align the syllabi with industry and academic requirements. There was a brief discussion by the Board on the proposed change in the title for the current Bachelors of Mass Media and Communication degree to Bachelor of Arts in Media and Communication. Dr. Salunkhe requested to know the criteria for changing the title which was stating that the value for a B.A. title is substantially more in the industry but also recommended drawing out the purpose of the proposed change of nomenclature by adjudging its rationale.

The Principal, Dr. Lokur added that the changes have to be governed by University of Mumbai regulations as well and not simply made to effect change.

The departments with minor changes in syllabi and structure briefed the board of the aforementioned. The standout change overall was drawn out to be the introduction of PhD coursework by Microbiology and Botany departments and also History and Hindi Departments.

Dr. Soman recommended adding a brief of these changes to the next Meeting's presentation to allow the Board to review the same efficiently.

Dr.Salunkhe suggested sharing and updating current trends in the market and industry and changes happening at a global level with students, so as to create awareness amongst them. This was encouraged by the Dean of Academics and the Principal who reiterated that this was a part of Ruia's Core Vision and Mission to upgrade and update students to global citizens.

The Board also suggested to adopt an inter-disciplinary approach and transfer of credits at Third Year level. However, theyagreed that Choice-based subject offering would be difficult at the present juncture but the same was offered for Applied Component and is working successfully. The Principal further justified by affirming that Certificate Courses offered by the College were a step towards creating inter-disciplinary perspectives for students.

The Member Secretary asked the permission of this body to allow these changes in the syllabus and it was resolved that these changes will be implemented from the academic year 2019- 20.

Dr. Sujata Suvarnapatki conveyed that no new Courses had been instituted after the last meeting of the Board but they did intend to start courses in collaboration with Montgomery County Community College, USA. She placed the list of Certificate Courses offered by Montgomery County Community College, USA before the Board, explaining that each course open to all inhouse students, irrespective of department to which the belonged, worth 03 Additional Credits and charged separately.

The Council deliberated on the structure of these Courses, their respective syllabi, the in-take capacity of these programmes and the fee structure to be recommended for the same.

Prof. Samant recommended first formalizing the MoU with the aforementioned Institute. It was also suggested that more Colleges in the USA, especially Ivy League Colleges like Harvard can also gradually be tapped for collab courses. This would help with managing on teacher workloads, effective and shared cost and pricing of the courses as well as shared teaching learning practices.

It was RESOLVED THAT institution of above listed Certificate Courses needs further deliberation necessary further action to be passed through circulation before the next Academic Council meeting.

# Agenda item No.04: To frame rules for the conduct of examinations, rules of students' evaluation

The Exam In-charge apprised the members of the last meetings amendments and recommendations, explaining the 60 external/ 40 internal evaluation pattern. The members deliberated the idea of Revaluation of answer books whereby minimum 20% of total marks obtained (minimum 12 marks out of 100) has to be targeted rise if Answer books have to be submitted by student for Revaluation. Dr. Samant and Dr. Soman both suggested altering the practice of revaluation and providing photocopy of the answer booklets to students. There were no further major changes in evaluation pattern to be discussed by the Council.
